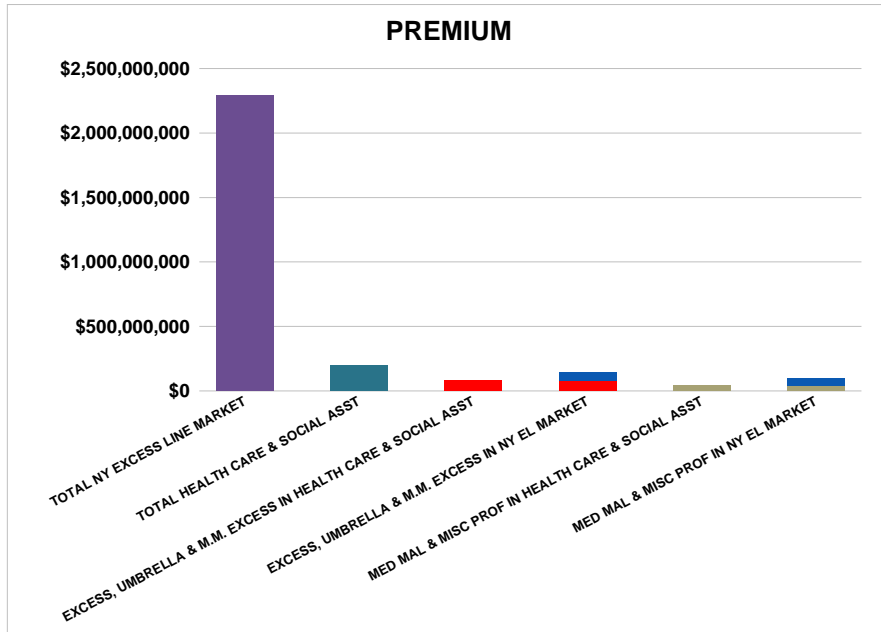

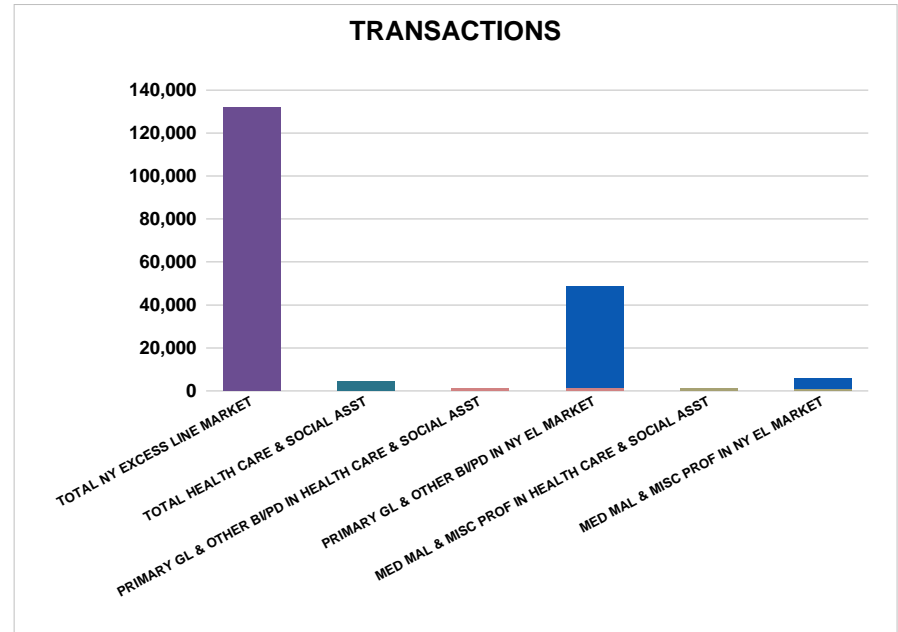


Top Coverage Categories in the Health Care And Social Assistance Industry by Premium
