

## ELANY List of Alien Insurers

The insurers below are listed in the most recent release of the NAIC's Quarterly Listing of Alien Insurers and as such are eligible to write excess line insurance in New York and have been added to ELANY's systems to allow processing of broker filings. It remains the responsibility of the excess line broker under §2118 of the New York Insurance Law and §27.13 of Regulation 41 to use "due care" in selecting the unauthorized insurer from whom policies are procured. Brokers must obtain and maintain records as required by §27.13 of Regulation 41.
