

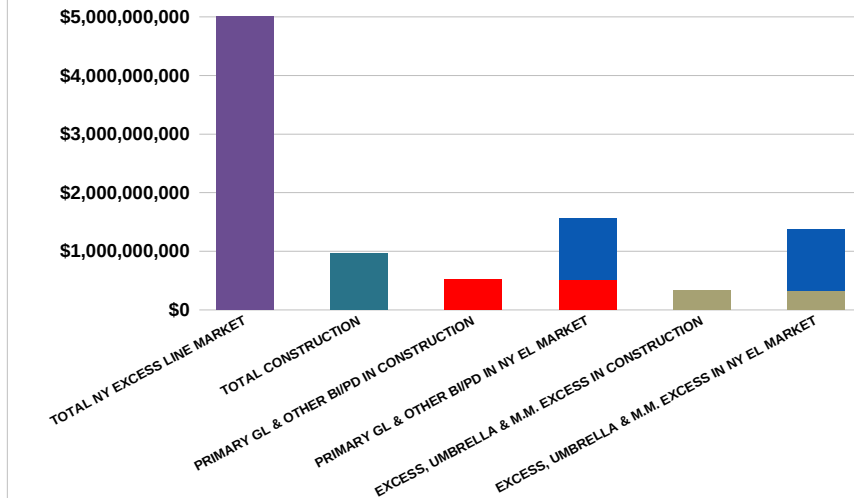

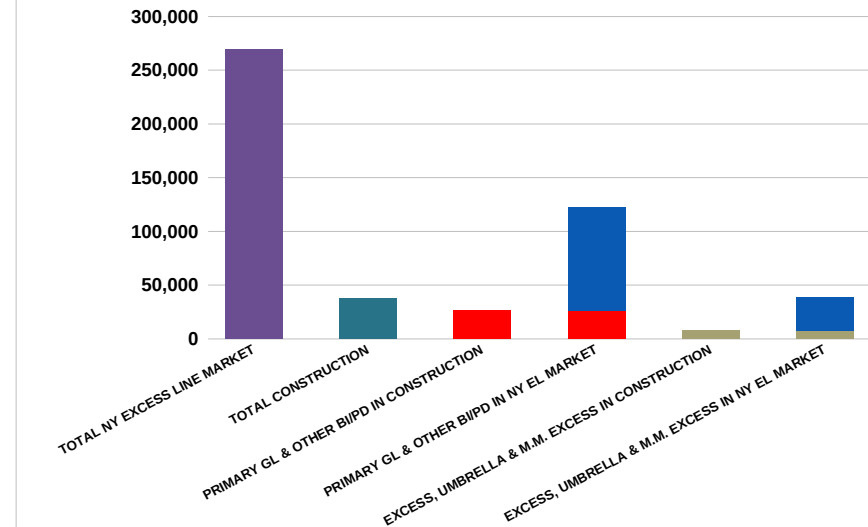


Top Coverage Categories in the Construction Industry by Premium
