

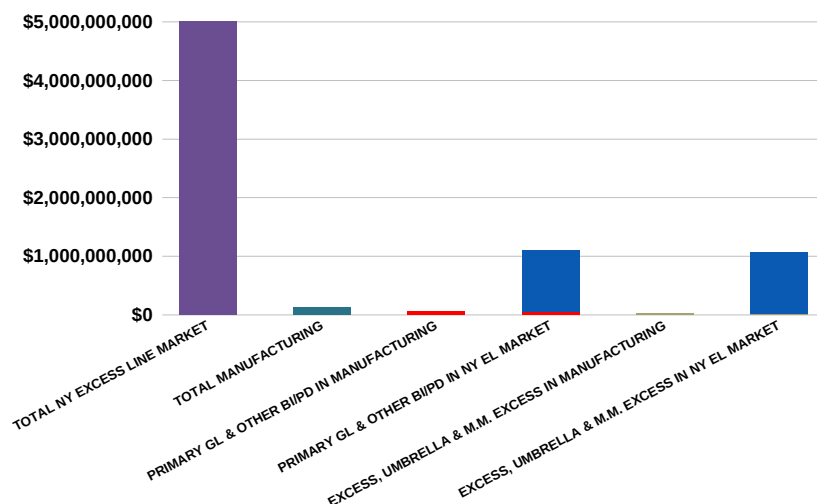

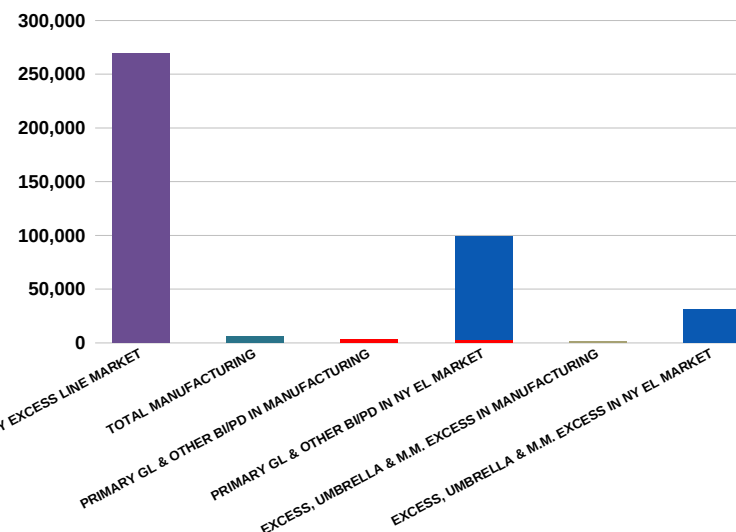


Top Coverage Categories in the Manufacturing Industry by Premium
