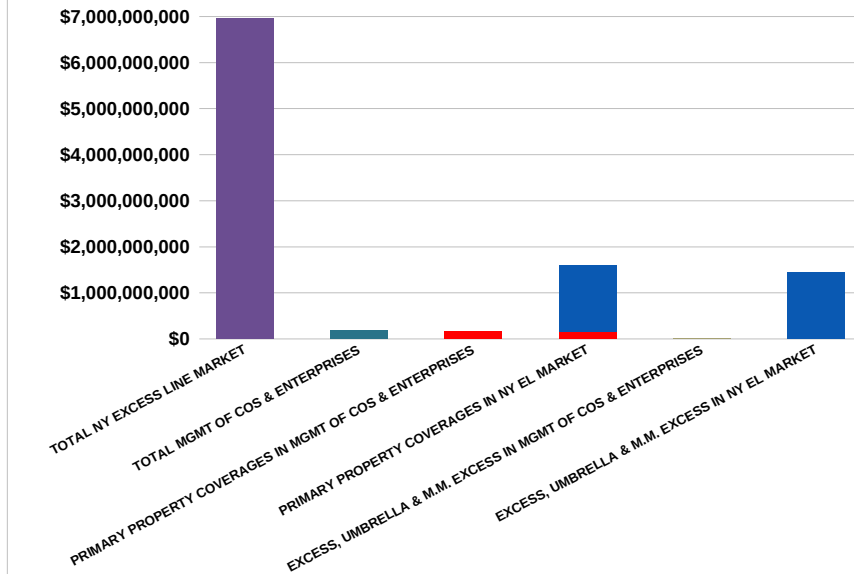

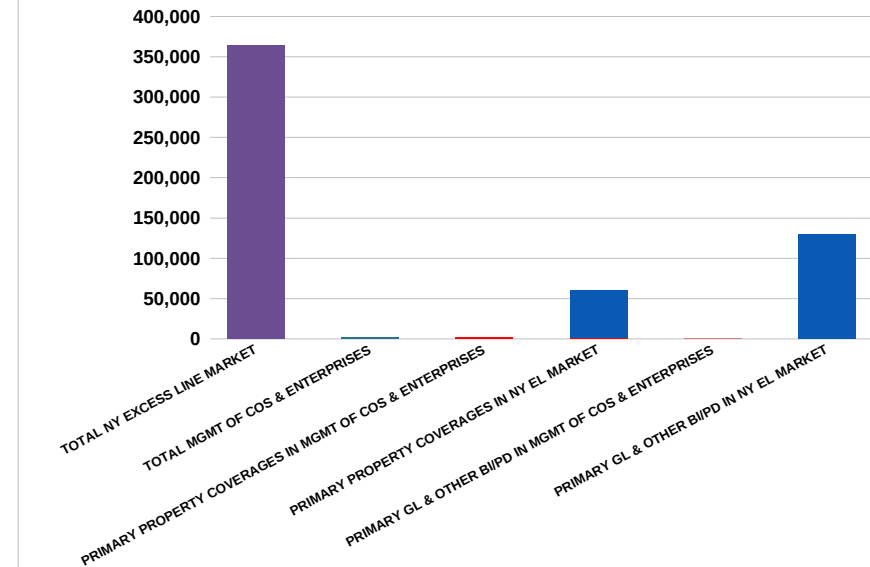


Top Coverage Categories in the Management Of Companies And Enterprises Industry by Premium
