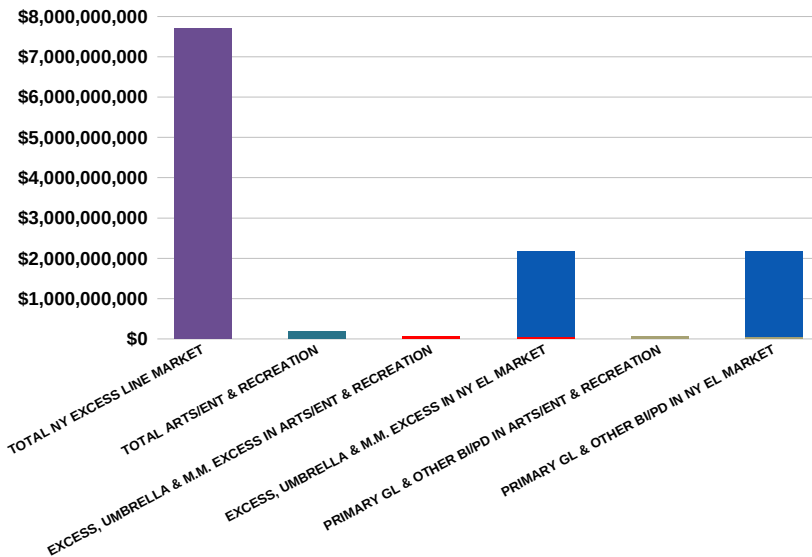

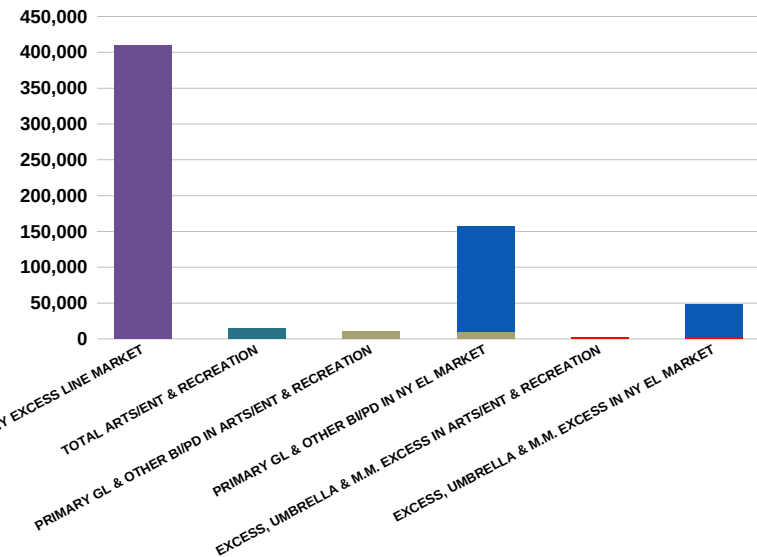


Top Coverage Categories in the Arts/Entertainment, And Recreation Industry by Premium
